Update on Issues

Factor

Springfield

Play Area

It was mentioned that the trampolines have been removed and the existing holes have half filled in with sand. One of trampolines had to be removed due to changes in ROSPA guidelines for safety due its proximity to a slope and other was removed because the safety edging around the trampoline was in a poor state of repair and caused a danger to users.

Road Safety

Additional 20mph signs have been requested for Mercer Street.

SUDS Pond

The gates/fencing to prevent the public from using the path across the weir are ready for installation. This is a Springfield initiative to stop pedestrians using the weir to cross SUDS pond. Springfield say that the weir was never designed for pedestrian usage.

Bertha Park Events Proposal

Andrew from Starfish has approached the group with a proposal to run events on Bertha Park. PKC have indicated that they are willing to consider this proposal. A figure of £3,500 has been suggested as a start-up amount to cover the necessary licences and insurances. GD and MO will meet with Andrew to discuss his proposal in further detail.

Link Road Public Exhibition

A public exhibition on the layout and design for the Bertha Park link road to the Discovery Bridge has been suggested for 24^{th} July in the Hub. To be confirmed.
